Re: Swine Identification for Iowa County Fair

Dear Swine Project Members and Leaders,

Welcome to all new and existing swine exhibitors! It is that time of year when you will need to identify your animals to show at the fair. Enclosed you will find directions for identification as well as general swine project information.

#### **IDENTIFICATION PROCESS:**

To exhibit your pigs at the fair, every animal needs to first be "identified". If pigs are not identified, you cannot enter them to be shown at the Iowa County Fair in August. NO exceptions!

We will again be using the RFID tag identification system. Every pig that is going to be identified for the show will need an electronic Radio Frequency Identification (RFID) tag. Superintendents will check ear notches and tag numbers with identification forms at fair check in. Please follow the steps below to correctly identify your animals.

**Step 1: Request tags.** Tags can be requested/purchased from the Iowa County Fair, a local veterinarian, Wisconsin State Fair, or a tag distributor. Wisconsin State Fair RFID tags are acceptable even if your animal <u>wasn't</u> exhibited at Wisconsin State Fair.

- Iowa County Fair has tags for purchase at \$3.00 per tag. If purchasing from the fair, request your tags by emailing, calling, or texting Morgan Worek by **May 3<sup>rd</sup>**, **2024**.

**Step 2: Obtain Tags.** If purchased through the fair, you will need to pick up and pay for your tags on the date listed below. If you cannot make any of this time, please contact Morgan to make other arrangements or have tags mailed to you.

Saturday, May 4<sup>th</sup> from 9:00 a.m. to 10:00 a.m. at the Iowa County Fair Office in Mineral Point

**Step 3: Place RFID tag in pig's ear.** Please see attached sheet for information on how to tag your animal. Note that it needs to be placed in the <u>animal's right ear (if you are standing behind your animal)</u>. We have ear taggers available if needed.

Step 4: Take a rear-view full head picture showing the RFID tag (in the ear) <u>AND</u> the pig's ear notches. Then, fill out the Identification Form.

• If your animal loses its tag throughout the show season, please contact Morgan immediately for a replacement.

# Step 5: Turn in all ID materials by May 20th, 2024.

- If your identification paperwork is not submitted by May 20<sup>th</sup>, 2024, you **will not** be able to exhibit at the Iowa County Fair.

#### **GENERAL INFORMATION:**

The swine show will still be a non-terminal show which requires animals to have a negative PEDv/PRRS test. There will be more information about testing in the coming months.

All show pigs will need to meet certain weight requirements. Show weight classes start at 230 lbs. with no upper weight limit. The minimum auction selling weight is 230 lbs. and maximum auction selling weight will be 285 lbs. If your animal exceeds this weight, it will still be allowed to sell, but the exhibitor will only be reimbursed for up to 285 lbs.

Youth will be allowed to sell one animal in the lowa County Fair livestock auction.

**WEIGH-IN:** Swine weigh-in/ check-in for the fair will be held Wednesday, August 28<sup>th</sup> from 6:30- 9:00 p.m. and Thursday, August 29<sup>th</sup> from 8:00-10:00 a.m. in the swine barn.

**SHOW DATE:** Gilt show is Thursday, August 29<sup>th</sup> at 6:00 p.m. Barrow show followed by showmanship on Friday, August 30<sup>th</sup> at 8:00 a.m.

#### **ADDITIONAL EVENTS IN SWINE BARN:**

Pee Wee Showmanship will follow the gilt show on Thursday, August 29<sup>th</sup>. It is open to youth who are too young to show in 4-H. We ask that participants be at least 3 years old. Interested kids should gather around the swine barn bleachers at the conclusion of the gilt show for directions.

Bacon Buddies will be held at 3:00 p.m. on Friday, August 30<sup>th</sup>. This show gives individuals with disabilities a chance to show a pig with our youth swine exhibitors. More information to come.

### **RULE REMINDERS**:

- We ask that animals not enter the barn until fair check-in on Wednesday, August 28<sup>th</sup> at 6:30 p.m. We need to receive all health papers prior to animals entering the barn to ensure that animals are disease free and cleared by a veterinarian.
- If your animal is not being sold in the auction, then you will have to provide <u>your own</u> transportation for that animal on Monday, September 2<sup>nd</sup>. Swine will no longer be able to get on the trailer provided by the fair due to liability reasons- even if it is going to the same packing plant.
- For animals that are not sold in the auction, the release time (dictated by the state of Wisconsin) is now 4:00 p.m. on Monday, September 2<sup>nd</sup>.
- **NEW THIS YEAR**: Barrows <u>AND</u> gilts that were shown at the Wisconsin State Fair <u>WILL BE</u> allowed to exhibit at the lowa County Fair in 2024.
- If you're planning to have a substitute show person, you must notify the superintendent in advance.

- The use of oils is no longer prohibited at the show.
- If a home born and raised pig wins the Overall Champion award, it <u>is eligible</u> to return to the ring to compete for the Home Born and Raised Champion.

**PREMISE ID**: All farms or locations that house animals in Wisconsin are required to have a Premise ID Number. If you do not have one, go to <a href="https://wiid.org/premises-registration">https://wiid.org/premises-registration</a> to register. There is no cost associated. You will need this number for your entry form.

YQCA: <u>ALL</u> exhibitors showing either dairy, beef, swine, sheep, goats, rabbits, and poultry at the lowa County Fair are required to attend Youth for the Quality Care of Animals (YQCA) either in person or online. This is required to exhibit at state fair also. You can complete the course online at <a href="https://yqcaprogram.org/">https://yqcaprogram.org/</a> or you can attend an in-person seminar-summer 2024 dates to be announced in the next 4-H newsletter.

• **FFA members**- <u>You</u> are responsible for notifying the Fair office to let them know when you complete YQCA. Your advisor will no longer be contacting the office to notify them.
